

Any waiver requests received by the WBYAA from other programs will be subject to review pursuant to the following South Shore Soccer Rules:

Section III Rule 3.1.1 of the South Shore Soccer League 11 vs. 11 rules:

3.1.1. . .the player shall reside in the SSSL Town they are playing for on the day of the first game of the season or have obtained written permission of the President of the SSSL Town in which they live and the President of the SSSL Town that they want to play for. A Copy of this written permission will be provided to the SSSL Registrar before the player may be added to the team's roster. If the player lives in a Town outside of the SSSL, then a League's Committee Inter League Form or its equivalent must be completed and provided to the SSSL Registrar before the player may be added to the team's roster.

Section 10.5 of the South Shore Soccer League Bylaws:

10.5. All players on teams eligible to represent the South Shore Soccer League at the Massachusetts Tournament of Champions shall reside in member towns of the South Shore Soccer League. A player residing in one town can play for a team in another town only when both towns agree on the move, and it has been approved by the South Shore Soccer League Executive Board. (A signed letter or email from the town President receiving the player shall be sent to the town President of the town releasing the player. This letter signed by both town Presidents shall be forwarded to the South Shore Soccer League Executive Board for approval.) If either town is opposed to the player's movement, the player will be required to play with the team from the town that he/she resides in. NOTE: If there is no team available for the player in his/her town, he/she can play on the team of his/her choice. In addition, if a player attends school in another town, that player has the option of playing for the team in the town in which they reside or the town they attend school in. No release is required under this scenario. Notice of the transfer must be provided to the home registrar. The player must provide proof of enrolment upon request of the registrar. Any player, who wishes to transfer from one league to another league, must have a written agreement signed by both town Presidents and both league Presidents for the transfer to be valid for MTOC eligible teams. If a town decides to move a player from one town not wanting the move, that town's teams will not be eligible for MTOC competition. If a team decides to accept a player despite the town does not want the move, that team will not be eligible for MTOC play. Any violations may be subjected to the following penalties: A. A Forfeiture of all games that the player played. B. Declared eligible for post season play. C. Two (2) year suspension of the coaches using the player. D. Fifty (\$50) dollar fine will be assessed to the Association that registered the player.

Pursuant to the above rules, any West Bridgewater athlete or other program that requests a waiver is subject to review on a case-by-case basis. Requests shall be decided based on the needs of the town rosters as well as other factors as they arise. Any waiver granted or denied is only applicable on a year-to-year basis and is not recurring.

If a waiver request is filed, the following process will start:

1. The Spring Committee will meet for discussion and end with a recommendation.
2. The recommendation will be moved forward to the EBoard for discussion.
3. Final decision rests with the Spring Commissioner and WBYAA President.
